I agree to follow the requirements of the laws, codes and ordinances of the Charter Township of Bangor. I understand an inspector is authorized to inspect the construction until work is completed and a final inspection sticker or certificate of occupancy is issued. I understand it is my responsibility to notify the inspector when the construction is ready for all inspections.

“Section 23a of the State Construction Code Act of 1972, 1972 PA 230, MCL 12A, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or a residential structure. Violators of section 23a are subjected to civil fines.”

HOMEOWNER AFFIDAVIT: I hereby certify the plumbing work described on this permit shall be installed by myself in my home which I am living or about to occupy. All work shall be installed in accordance with the Plumbing code and shall not be enclosed, covered up or put into operation until it has been inspected and approved by the Plumbing Inspector. Ref. #1 above: (PLEASE CIRCLE FIXTURES AND INCLUDE QUANTITIES OF EACH) water closets, bathtub, lavatories, slop sink, shower stall, laundry tray, sink (any description), dishwasher, garbage disposal, refrigerator with water, domestic hot water heater, automatic washer, floor drain, swimming pool, catch basin or sump pump, water softener, ice making machine, drinking fountain, urinal roof drain, grease trap, starch trap, plaster trap, condensation drain, acid wash drain, bed pan washer, bidet, cuspidor, emergency eye wash, emergency shower, water outlet cooler, water connection to carbonated beverage dispensers, water connection to any make-up water tank, water outlet or connection to heating system, water outlet or connection to filters, connection to sprinkler system (irrigation), water connected sterilizer, water connected dental chair, plus any other fixture, drain or water connected appliance not specifically listed.

Ref. # 2 above: When setting a mobile home in a park, or a mobile or modular home on private property, a permit shall include the application fee, a sewer or building drain, gas piping and a water service or water distribution pipe. When item is used for sewer excavations in a new park, the permit application should include the application fee plus the number of unit sites.

General: Plumbing work shall not be started until the application for permit has been filed. All installations shall be in conformance with the Plumbing Code. **No work shall be concealed until it has been inspected.** When ready for an inspection, call the inspector providing as much notice as possible. The inspector will need the **job location and permit number.**

Expiration of Permit: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CANCELED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELED PERMITS CANNOT BE REFUNDED OR REINSTATED.**
